

1. On 31 January 2011, the Prosecution filed the “Public with Confidential Annexes Prosecution Motion for an Investigation into Contempt of the Special Court for Sierra Leone.”¹
2. The Prosecution notes that there is an editorial error on page 9, paragraph 29 of that Motion. The second sentence of paragraph 29 states: “To the knowledge of the Prosecution, the Registrar did *not* investigate the incidents reported in the memorandum and apparently determined that there was not an immediate threat to Prosecution witnesses” (emphasis added). This sentence should read as follows: “To the knowledge of the Prosecution, the Registrar *did* investigate the incidents reported in the memorandum and apparently determined that there was not an immediate threat to Prosecution witnesses.”
