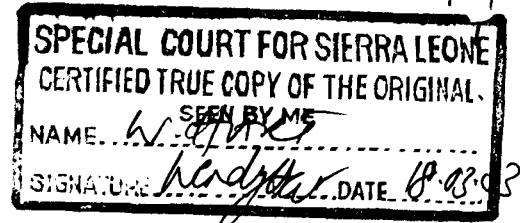
In accordance with Rule 55C of the Rules, I kindly request the following assistance:

- 4) That you ensure the immediate execution of the Order and transfer of the suspect to the Special Court. In this connection, I would like to draw your attention to the fact that according to Part V and VI of the Special Court Agreement, 2002 (Ratification) Act, 2002, orders of the Special Court have the same force or effect as if they had been issued by a Judge, Magistrate or Justice of Peace of a Sierra Leone Court. Further, I would like to recall the obligation of Sierra Leone to cooperate with the Special Court in accordance to Article 17 of the Agreement establishing the Special Court; as well as Rules 56 and 57 of the Rules, which require prompt and effective action in the execution of the said Warrants and Orders.

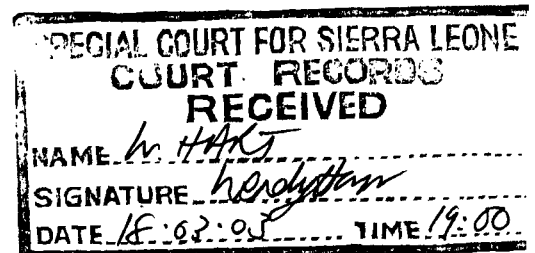

**ORDER FOR TRANSFER AND PROVISIONAL DETENTION PURSUANT TO
RULE 40BIS**

THE SPECIAL COURT FOR SIERRA LEONE (“the Special Court”),

WITH Judge Benjamin Mutanga Itoe, presiding pursuant to the provisions of Rule 28 and Rule 40 of the Rules of Procedure and Evidence (“the Rules”);

HAVING RECEIVED on the 17th March, 2003 from the Prosecutor pursuant to Rule 40 *bis*, a request for the transfer and provisional detention of the suspect, AUGUSTINE GBAO, former officer in the Sierra Leone Police Force;

CONSIDERING the affidavit dated 14th of March, 2003, attached to the said request from the Prosecutor and signed by Morrie Lenghor, Investigator at the Office of the Prosecutor;

CONSIDERING the formal request dated 14th of March, 2003, addressed by the Prosecutor to the authorities of the Republic of Sierra Leone pursuant to Rule 40 of the Rules to arrest and hold in custody the said suspect, AUGUSTINE GBAO;

WHEREAS the authorities of the Republic of Sierra Leone granted the said request of the Prosecutor and are holding AUGUSTINE GBAO in custody;

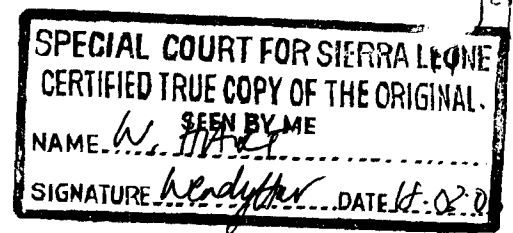
WHEREAS the Prosecutor reports that he is investigating crimes allegedly committed by AUGUSTINE GBAO in the territory of Sierra Leone since 30 November 1996, crimes which fall within the jurisdiction of the Special Court;

WHEREAS, according to the Prosecutor, AUGUSTINE GBAO participated in widespread attacks against UNAMSIL peacekeepers and personnel, including the unlawful killing and abduction of UNAMSIL peacekeepers;

WHEREAS the Special Court considers, on the basis of the request submitted by the Prosecutor, and on the evidence brought to its attention in the affidavit attached to the request, that there is a reason to believe that AUGUSTINE GBAO may, in the light of the above have committed **SERIOUS VIOLATIONS OF INTERNATIONAL HUMANITARIAN LAW, CRIMES AGAINST HUMANITY, VIOLATIONS OF ARTICLE 3 COMMON TO THE GENEVA CONVENTIONS AND OF ADDITIONAL PROTOCOL II**, punishable respectively under Article 4.b., Article 2.a., Article 3.a. and Article 3.c. of the Statute of the Special Court (“the Statute”);

WHEREAS, furthermore, the Prosecutor contends that the provisional detention of AUGUSTINE GBAO is a necessary measure to prevent his escape and also to prevent the suspect from seeking to intimidate or to cause bodily harm to victims or witnesses or to destroy evidence, or to be otherwise necessary for the conduct of the investigation in the matter concerning him;

WHEREAS, the Judge, in the light of the above, is convinced that the provisional detention of AUGUSTINE GBAO is necessary;




NOW THEREFORE: I, Judge Benjamin Mutanga Itoe, for all the aforementioned reasons advanced by the Prosecutor, rule that the request submitted by the Prosecutor for the transfer and provisional detention of AUGUSTINE GBAO satisfies the conditions laid down by Rule 40 *bis* (B) of the Rules;

ON THESE GROUNDS,

GRANT the request submitted by the Prosecutor and consequently, order that AUGUSTINE GBAO be transferred as soon as possible to the Detention Facility of the Special Court, and be kept in provisional detention for a maximum of thirty days, with effect from the day after his transfer, and that he, in accordance with Rule 40 *bis* (J) of the Rules, be brought before me or another Judge designated under Rule 28 of the Rules, to ensure that his rights are respected;

INSTRUCT the Registrar to serve the present Order on the Authorities of the Government of Sierra Leone, for its immediate execution pursuant to the provisions of Section 20 of the Special Court Agreement 2002 (Ratification) Act.

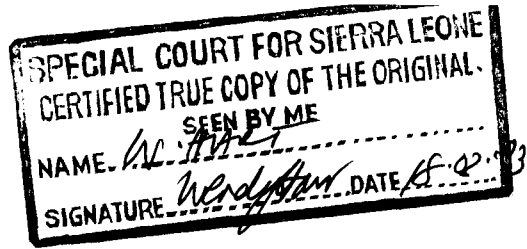

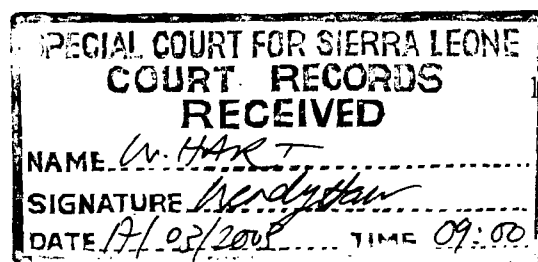

REQUEST FOR TRANSFER AND PROVISIONAL DETENTION UNDER ARTICLE 40 BIS OF THE RULES OF PROCEDURE AND EVIDENCE OF THE SPECIAL COURT FOR SIERRA LEONE

TO ONE OF THE HONOURABLE JUDGES SITTING PURSUANT TO RULE 28 OF THE RULES OF PROCEDURE AND EVIDENCE OF THE SPECIAL COURT FOR SIERRA LEONE:

I, DAVID M. CRANE, Prosecutor of the Special Court for Sierra Leone, pursuant to the authority given to me by Rule 40 *bis* of the Rules and Procedure and Evidence of the Special Court for Sierra Leone (hereafter "the Rules") request the issuance of an Order for the transfer and provisional detention of AUGUSTINE GBAO in the premises of the detention unit of the Special Court on the following grounds:

1. On Friday 14 March, 2003 pursuant to the authority given to me by Rule 40 I requested the Republic of Sierra Leone Police Force to arrest AUGUSTINE GBAO and place him in custody in accordance with the laws of Sierra Leone.
2. The Office of the Prosecutor is currently investigating AUGUSTINE GBAO for crimes committed within the territory of Sierra Leone and within the temporal jurisdiction of the Special Court namely:



- A. CRIMES AGAINST HUMANITY, punishable under Article 2 of the Statute of the Special Court (hereafter “the Statute”).
 - B. VIOLATIONS OF ARTICLE 3 COMMON TO THE GENEVA CONVENTIONS AND OF ADDITIONAL PROTOCOL II, punishable under Article 3 of the Statute.
 - C. OTHER SERIOUS VIOLATIONS OF INTERNATIONAL HUMANITARIAN LAW, punishable under Article 4 of the Statute.
3. It appears from these investigations, particularly from the information contained in the affidavit of MORIE LENGHOR annexed hereto, that there is evidence that AUGUSTINE GBAO may have committed crimes over which the Court has jurisdiction, and which may give rise to the following provisional charges:
- A. Between 23 December, 1999 and 31 December, 2000, AUGUSTINE GBAO and other members of the AFRC/RUF alliance looted an unknown number of civilian homes in Makeni, Bombali District in the Northern Province Sierra Leone.

By his acts and omissions in relation to, but not limited to these events, AUGUSTINE GBAO, pursuant to Article 6.1. and or alternatively, Article 6.3. of the Statute, is individually criminally responsible for the crime alleged below:

PILLAGE, a Violation of Article 3 Common to the Geneva Conventions 1949 and of Additional Protocol II, punishable under Article 3f of the Statute of the Special Court for Sierra Leone (hereafter “the Statute”).

- B. Between about 15 April, 2000 and about 15 September, 2000, AFRC/RUF forces including AUGUSTINE GBAO engaged in widespread attacks against UNAMSIL peacekeepers and humanitarian assistance workers within the Republic of Sierra Leone, including but not limited to locations within Bombali, Kailahun, Kambia, Port Loko and Kono Districts. These attacks included unlawful killing of UNAMSIL peacekeepers, and abducting hundreds of peacekeepers and humanitarian assistance workers who were then held hostage.

By his acts or omissions in relation, but not limited to these events, AUGUSTINE GBAO, pursuant to Article 6.1 and, or alternatively, Article 6.3 of the Statute, is individually criminally responsible for the crimes alleged below:

INTENTIONALLY DIRECTING ATTACKS AGAINST PERSONNEL INVOLVED IN A HUMANITARIAN ASSISTANCE OR PEACEKEEPING MISSION, which constitutes OTHER VIOLATION OF INTERNATIONAL HUMANITARIAN LAW, punishable under Article 4 b of the Statute.

For the unlawful killings:

MURDER, A CRIME AGAINST HUMANITY punishable under Article 2a of the Statute;

In addition, or in the alternative:

VIOLENCE TO LIFE, HEALTH AND PHYSICAL OR MENTAL WELL-BEING OF PERSONS, in particular, MURDER, a Violation of Article 3 Common to the Geneva Conventions 1949 and of Additional Protocol II, punishable under Article 3a of the Statute.

For the abductions and holding of persons as hostages:

TAKING OF HOSTAGES, a Violation of Article 3 Common to the Geneva Conventions 1949 and of Additional Protocol II, punishable under Article 3a of the Statute.


- 4. I submit that the provisional detention of AUGUSTINE GBAO is a necessary measure to prevent his escape, physical or mental injury to or intimidation of a victim or witness or the destruction of evidence, or to be otherwise necessary for the continued conduct of the investigations.

ACCORDINGLY, I REQUEST THAT YOU GRANT ALL ASPECTS OF THE PRESENT REQUEST AND THEREBY:

- A. **DECLARE** that there is reason to believe that AUGUSTINE GBAO may have committed the crimes specified in the provisional charges above, over which charges the Special Court has jurisdiction;
- B. **CONSIDER** provisional detention to be a necessary measure to prevent the escape of AUGUSTINE GBAO, physical or mental injury to or intimidation of a victim or witness or the destruction of evidence, or to be otherwise necessary for the conduct of the investigation;
- C. **ORDER** the transfer of AUGUSTINE GBAO from the custody of the Sierra Leone Police to the detention premises of the Special Court; and
- D. **ORDER** that AUGUSTINE GBAO be provisionally detained for an initial period not exceeding 30 days from the day of the transfer at the detention unit of the Special Court.

RIGHTS OF SUSPECT

Rules of Procedure and Evidence of the Special Court for Sierra Leone

Rule 42: Rights of Suspects during Investigation

(A) A suspect who is to be questioned by the Prosecutor shall have the following rights, of which he shall be informed by the Prosecutor prior to questioning, in a language he speaks and understands:

- (i) The right to be assisted by counsel of his choice or to have legal assistance assigned to him without payment if he does not have sufficient means to pay for it;
- (ii) The right to have the free assistance of an interpreter if he cannot understand or speak the language to be used for questioning; and
- (iii) The right to remain silent, and to be cautioned that any statement he makes shall be recorded and may be used in evidence.

(B) Questioning of a suspect shall not proceed without the presence of counsel unless the suspect has voluntarily waived his right to counsel. In case of waiver, if the suspect subsequently expresses a desire to have counsel, questioning shall thereupon cease, and shall only resume when the suspect has obtained or has been assigned counsel.

Rule 43: Recording Questioning of Suspects

Whenever the Prosecutor questions a suspect, the questioning shall be audio-recorded or video-recorded, in accordance with the following procedure:

- (i) The suspect shall be informed in a language he speaks and understands that the questioning is being audio-recorded or video-recorded;

Right of Suspects - Rules of Procedure and Evidence of the Special Court for Sierra Leone

(ii) In the event of a break in the course of the questioning, the fact and the time of the break shall be recorded before audio-recording or video-recording ends and the time of resumption of the questioning shall also be recorded;

(iii) At the conclusion of the questioning the suspect shall be offered the opportunity to clarify anything he has said, and to add anything he may wish, and the time of conclusion shall be recorded;

(iv) The content of the recording shall then be transcribed as soon as practicable after the conclusion of questioning and a copy of the transcript supplied to the suspect, together with a copy of the recording or, if multiple recording apparatus was used, one of the original recorded tapes; and

(v) After a copy has been made, if necessary, of the recorded tape for purposes of transcription, the original recorded tape or one of the original tapes shall be sealed in the presence of the suspect under the signature of the Prosecutor and the suspect.




