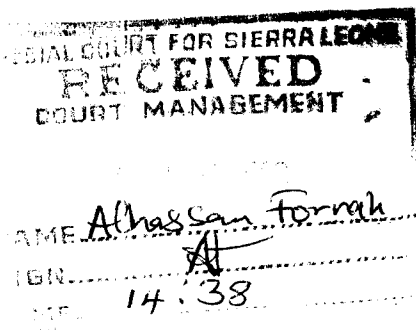

1. On 19 May 2008, the Trial Chamber granted leave to the Defence for the Third Accused to call four additional witnesses.¹
2. In accordance with the Trial Chamber's order of 1 March 2007,² the Defence for the Third Accused herewith discloses, in confidential Annex A, the identity of the three protected witnesses who are added to the witness list for the Third Accused.
3. The Defence for the Third Accused wishes to bring to the attention of all the parties to the proceedings order (k) of the Trial Chamber decision granting protective measures to the witnesses to testify for the Third Accused, which states the procedure to be followed should any of the parties intend to interview the witnesses mentioned:

Upon disclosure of the witness' names or any other identifying data by the Defence pursuant to order (c) above, the Prosecution, the Defence for the First Accused, Issa Sesay, and the Defence for the Second Accused, Morris Kallon, respectively shall inform the Witnesses and Victims Section of their intention, if any, to interview a witness listed as a witness for the Defence for the Third Accused, Augustine Gbao. The Witnesses and Victims Section, upon being informed beforehand of the location of the witness, shall contact the witness and inform him or her of any party's intention to interview him or her and of his or her right not to consent to give the interview. Should the witness consent to the interview, the Witnesses and Victims Section shall inform the relevant party as to the location for the interview. Except under exceptional circumstances, any such interview should not take place at the outset of the witness' testimony in court.³
