Pursuant to Rule 68, filed by the Sesay Defence on the 23rd of April 2007 ("Reply");

NOTING that in the Application the Prosecution applies for leave to file a further response to the
Motion in order to correct factual errors, which the Prosecution alleges the Sesay Defence has made
in the Reply and to have the Application accepted as such further response;¹

THE CHAMBER HEREBY GRANTS the Application


AND ORDERS the Sesay Defence to file a response to the Application within three days of the date
