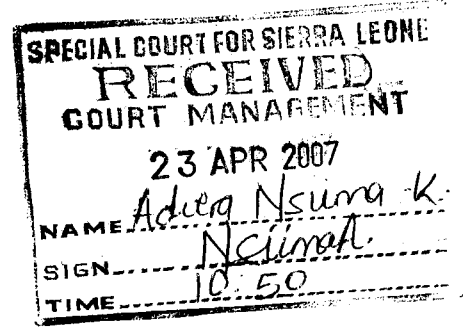

**TRIAL CHAMBER II** (“Trial Chamber”) of the Special Court for Sierra Leone (“Special Court”), composed of Justice Julia Sebutinde, Presiding Judge, Justice Richard Lussick and Justice Teresa Doherty;

**SEISED** of the “Prosecution Corrigendum & Motion for Leave to Substitute Pages of the Prosecution Rule 73bis Pre-Trial Conference Materials”, filed on 17 April 2007 (“Motion”) correcting certain typographical and other errors in the Pre-Trial Conference Materials and requesting an order that the original pages of the Pre-Trial Conference Materials be replaced by the corrected pages set out in the annexes attached to the Motion;

**NOTING** that the Defence does not intend to file a response to the Motion;<sup>1</sup>

**RECALLING** the Prosecution “Rule 73bis Pre-Trial Conference Materials” comprising (i) Pre-Trial Brief; (ii) Witness List; (iii) Summaries of Facts; (iv) Expert Witness List; and (v) Exhibit List, filed on 4 April 2007 (“PTC Materials”);


**CONSIDERING** that the Defence does not oppose the Motion and that the Motion merely seeks leave to substitute corrected pages for those pages of the PTC Materials that contain typographical errors and other errors, including the erroneous deletion of words between pages 13 and 14 of the Pre-Trial Brief and an erroneous signature page;


**HEREBY GRANTS THE MOTION**

**AND ORDERS** that the original pages of the PTC Materials be replaced by the corrected pages set out in the annexes attached to the Motion.

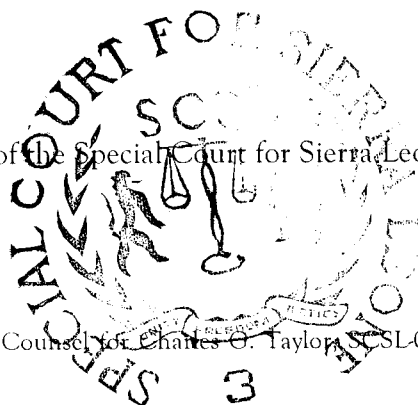
