DECISION ON THE PROSECUTION MOTION REQUESTING LEAVE TO AMEND INDICTMENT

Karim A.A. Khan Roger Sahota TRIAL CHAMBER II ("Trial Chamber") of the Special Court for Sierra Leone ("Specia! Court");

SEISED of the "Prosecution Motion Requesting Leave to Amend the Amended Indictment", filed on 14 May 2007, in which the Prosecution requests leave to amend the following counts of the Amended Indictment, which amendments are incorporated in a Second Amended Indictment attached to the Motion as Annex A, as follows:

- (a) Count 5 by deletion of the words "and any other form of sexual violence";
- (b) Count 11 by deletion of the word "Masiaka" from paragraph 30;
- (c) Count 11 by insertion between paragraphs 30 and 31 of a heading entitled "Port Loko District" and a paragraph numbered 30A which states "Between about 1 February 1998 and about 30 April 1998, in various locations, including Masiaka";¹

NOTING the "Defence Response to Motion Requesting Leave to Amend Indictment" filed on 18 May 2007 in which the Defence does not object to the proposed amendments to the Amended Indictment of 16 March 2006;²

NOTING that the Prosecution has not filed a Reply to the Response;

RECALLING that the original Indictment ("Indictment") against the Accused Charles Ghankay Taylor as filed by the Prosecutor on 3 March 2003 and approved³ by the Honourable Justice Bankole Thompson, Designated Judge on 7 March 2003 was first amended⁴ on 16 March 2006 ("Amended Indictment");

RECALLING the Accused Charles Ghankay Taylor made his initial appearance on 3 April 2006 pursuant to Rule 61 of the Rules of Procedure and Evidence ("Rules") before the Honourable Justice Richard Lussick and formally pleaded not guilty to all 11 counts of the Amended Indictment;

MINDFUL of the provisions of Article 17(4)(a) of the Statute of the Special Court for Sierra Leone ("Statute"), and of Rules 50(A), 52(A), and 73 of the Rules of Evidence and Procedure ("Rules");

SATISFIED that the proposed amendments do not cause any injustice to the accused, nor otherwise prejudice him unfairly in the conduct of his defence;⁵

HEREBY GRANTS the Prosecution leave to amend the Amended Indictment dated 16 March 2006 by substituting for the said Amended Indictment, the Second Amended Indictment which is attached to the Motion as Annex A.
