I. INTRODUCTION

1. This is the Defence's Response to the *Prosecution List of Documents Marked for Identification During the Testimony of Charles Taylor Sought to be Admitted into Evidence* ("**Prosecution Motion**"),¹ filed on 19 February 2010, but received by the Defence on the afternoon of Monday 22 February, with the deadline for responding thereto being Wednesday 24 February 2010.
2. In the *Defence Motion for the Admission into Evidence of 301 Documents and Photographs Marked for Identification During the Evidence-In-Chief of the Accused* ("**Defence Motion**"),² filed on 19 February 2010, the Defence sets out the applicable legal principles which in our submission govern the admissibility of evidence. The Prosecution does not dissent from our central proposition that the test to be applied is one of relevance.³
3. The Defence does not object to the admission into evidence of any of the documents used by the Prosecution during the cross-examination of the Accused, those being MFI-302(A) to MFI-407, where the relevance and hence admissibility of the document is for the sole purpose of challenging the credibility of the Accused and his evidence. However, it is clear from Annex 1 to the Prosecution Motion, that the purpose for which the admission of certain documents is sought, goes beyond mere impeachment and engages issues relevant to the guilt of the Accused. In relation to the documents so identified, it is submitted that the Prosecution must satisfy the "exceptional circumstances" test as decided by the Trial Chamber in its Documents Decision of 30 November 2009.⁴

II. APPLICABLE LEGAL PRINCIPLES

4. In the *Documents Decision*, the Trial Chamber held that the admission of documents containing fresh evidence deployed in cross-examination of the Accused in order to impeach his credibility would be determined on a case-by-case basis. However, in relation to fresh evidence probative of the guilt of the Accused, the Prosecution would be required to establish “exceptional circumstances” before any such document would be admitted.
5. Based on that understanding of the legal position, the Defence, save for a request for further and better particulars in relation to certain documents marked during the cross-examination of the Accused, accepted that all documents so produced could be admitted.
6. However, in its Motion (**Prosecution Motion**) the Prosecution despite asserting that: “*Since the Prosecution was precluded from using any fresh evidence that could potentially be probative of guilt, even for impeachment purposes only, there is no question of the “exceptional circumstances” test arising at this stage*”,⁵ nonetheless, in setting out its “arguments in support of admission” in Annex 1, on several occasions adopts language which suggests that the purpose sought for admission of certain documents goes beyond the sole purpose of impeachment but also implicates guilt.

III. ARGUMENT

7. The Defence identifies the following instances where the Prosecution seeks the admission of a document for a purpose going beyond mere impeachment:⁶
 - a MFI-334 (C): where it is suggested that the document not merely impeaches the suggestion by the Accused that he was point President for peace in Sierra Leone, but also that he was “...*very aware of what Bockarie was doing because he was acting with the Accused’s knowledge and control or consent*”.

- b MFI-334 (I) and MFI-334 (J): where it is suggested that the documents not merely impeach the Accused's testimony that he was working as the point President for peace in Sierra Leone, but is also relevant to his "*relationship with the Junta*".
- c MFI-334 (L): where it is suggested that the document: "*gives notice of ongoing crimes being committed against civilians by rebels in Sierra Leone*".
- d MFI-337: where it is suggested that the document not merely impeaches the Accused's testimony that he was the point President for peace in Sierra Leone, but also addresses his knowledge of a "*..report about rebels beheading men and women and chopping arms of others including children in a small village called Alikalia in December 1998 in retaliation for the death sentence passed against Sankoh*". It is of note that Alikalia is a location not pleaded in the Indictment.
- e MFI-345: where it is stated that the evidence: "*Impeaches the Accused's denials of criminal involvement with the rebels in Sierra Leone and his assertions that he was acting openly in regard to the presence of Sam Bockarie and his men in Liberia.*"
- f MFI-346, MFI-347, and MFI-348: in relation to all three documents it is asserted that not merely do these documents impeach the Accused's testimony that he was point President for peace in Sierra Leone, but they are also relevant to his denial of: "*...ongoing involvement with the rebels in Sierra Leone including the time period of his involvement.*"
- g MFI-348: it is here suggested that the document: "*Impeaches the Accused's testimony of his supposed role as the point President for peace in Sierra Leone and his denials of ongoing criminal involvement with the rebels in Sierra Leone. Also impeaches the Accused's testimony that he did not have knowledge that the rebels in Sierra Leone were engaged in a campaign of terror against civilians*".
- h MFI-370: it is here stated that the document: "*Impeaches the Accused's denials of criminal involvement with the RUF in that the GOL announced a*

“new policy of disengagement by which the Government would no longer support the activities of the RUF”.

8. The documents identified above demonstrate the force of the observation made by the Trial Chamber in the Documents Decision,⁷ that: *“...the borderline between cross-examination as to credit and cross-examination on issues that may be probative of his guilt is difficult if not impossible to determine”.*

IV. CONCLUSION


9. It is submitted that the Prosecution should be required to establish the “exceptional circumstances” which justify the admission of the documents listed above at paragraph 7 for a purpose which goes beyond the impeachment of the Accused.
10. Further, attached to this Response is an additional Schedule of the documents sought to be admitted by the Defence.⁸ In this Schedule the transcript reference for the individual documents marked has been added. We note *passim* that in their motion⁹ the Prosecution has not indicated which, if any, of the documents marked for identification by the Defence it objects to. Bearing in mind our understanding of the procedure, that it is for the party objecting to the admission of a document marked for identification to raise its objection and then for the opposing party to respond, in the absence of any objection by the Prosecution we seek admission of all 301 documents marked for identification during the evidence-in-chief of the Accused.
